Constitution and General Provisions

Student Government Association

of Palo Alto College, 2016-2017

Preamble

We, the students of Palo Alto College, in order to develop and maintain an understanding of the democratic processes will explore student concerns and provide an official student body voice through which student's opinions may be expressed, gain an awareness of the student's role in the academic community, and enhance the quality and encourage the development of our participation in the policy and decision making processes of the College. We do hereby establish this Constitution and Bylaws for the establishment of the Student Government Association of Palo Alto College.

Article I – Membership

Section (M-1)

The Student Community shall consist of all persons registered as students at Palo Alto College. All members of the Student Community are eligible to vote and are subject to the Constitution and Bylaws of the Student Government Association.

Section (M-2)

The elected officers of the Student Government Association shall be known as the Executive Officers of the Student Government, shall initiate all legislation on behalf of the Student Community, and shall have the right to address student concerns. The term of office will begin the first Monday after Graduation and end the last day of the Spring term.

Section (M-3)

The elected officers of the Student Government Association must agree to participate in and complete a leadership program and or attend a leadership training course during their elected term that will include but not limited to Student Leadership Institute, National Society of Leadership and Success, and The Seven Habits.

Section (M-4)

The Senators of the Student Government Association shall communicate student questions, concerns, and feedback to the Executive Officers. Applications for Senator Positions will be accepted no later than the last week of every month and their term will begin the first week of the following month.

<u> Article II – Organization</u>

Section (O-1)

The Executive Committee shall include a President, a Vice President, a Secretary of Business & Treasury, the Executive Officer of Student Life, the Executive Office of Student Resources, the Executive Officer of Campus Services, the Executive Officer of Academic Success, the Executive Officer of Senators, and the Executive Officer of Public Relations. These nine officers shall make up the Executive Branch of the Student Government Association. No office will be denied to any student on the basis of race, color, religion, gender, national origin, age, veteran status, genetic information, sexual orientation, disability.

Section (O-2)

Senators will be participating members of the Student Government Association and will expect to do three office hours a week under the supervision of an Executive Officer. Senators will be expected to attend and/or volunteer at three of each of the events, meetings, and activities listed in Section O-3 during the academic year. Senators can be appointed to an Executive Officer position in the event of a vacancy upon 2/3 approval of the Executive Committee.

Section (O-3)

All members of the Student Government Association will be expected to attend or be participating members of Paloween, NIOSA, PACfest, Student Health Advocacy Resource and Engagement (S.H.A.R.E) Center, PAC Gives Back, New Student Orientations (NSO), Celebracion, Club Rush, Alamo Colleges Board of Trustee Meetings, Student Body Meetings (SBM), Town Halls, Conference of Student Government Association (COSGA), Meetings with the President of the College, Student District Council (SDC), San Antonio Higher Education Representative Assembly (SAHERA), and Texas Junior College Student Government Association (TJCSGA), and any other scheduled meetings, committees, and events.

President

The President shall preside over all meetings and have the power to delegate among the officers. The President shall, in conjunction with the other officers, set the agenda for the meetings of the Students Government Association and shall preside over all meetings of the SGA. The President shall be responsible for executing the decisions of the Student Government Association. The President shall act as the official representative and spokesperson of the Student Government Association on all occasions. The President shall serve as the Chairperson of the Executive Committee. The President will vote only to break a tie.

Vice President

The Vice President shall preside over all meetings in the absence of the President and assume all duties of the President. The Vice President shall have the power to vote at all meeting when not assuming the position of President. Should the office of the President become vacant, the Vice President shall have the ability to assume the office of the President for the unexpired term, upon the majority approval of the Executive Committee. The Vice President will oversee the Student House of Representatives (SHOR) meetings and work alongside with the Secretary of Business & Treasury on the agendas. The Vice President is responsible for the nomination of the prospective student candidates, this will include student leaders from the Student House of Representatives (SHOR) to the Membership Committee for positions on various committees, boards, and panels established by the College in which the Student Government Association deems student participation most necessary.

Secretary of Business and Treasury

The Secretary of Business and Treasury's main duties will be to take minutes and create agendas that will be approved by the Executive Committee for the Student Government Association and Student House of Representative meetings and shall handle correspondence and keep accurate records of all other meetings. The minutes will be posted in the OrgSync system. The Secretary shall handle all financial records, deposits, and assist in fundraising activities.

Executive Officer of Student Life

The Executive Officer of Student Life will be the official representative on the Student Services Fee Advisory Committee. This officer will be responsible for managing the OrgSync system for the Student Government Association by keeping it up to date and attending the campus club and organization meetings. This Executive Officer will also be Chair of the Paloween Committee, communicate with the Student Life Office, and relay all information to the Executive Committee.

Executive Officer of Student Resources

The Executive Officer of Student Resources is concerned with student related problems, health services, counseling, open records, financial aid, and all other areas of students concerns relating to student services and special student populations. This officer will be in communication with the S.H.A.R.E. Center and will head the S.H.A.R.E. Committee.

Executive Officer of Campus Services

The Executive Officer of Campus Services is responsible for monitoring and communicating issues related to physical facilities and buildings, campus parking, food services, classrooms, equipment, disabled student accommodations, the Palo Alto College van and other areas of student concern related to the operations of the campus with Facilities and the Campus Police.

Executive Officer of Academic Success

The Executive Officer of Academic Success is concerned with issues related to instruction, curriculum, textbooks, transferring course credits, graduation, grading policies, and other areas related to student concerns relative to academic matters. This Officer will be in contact with the Admissions Office and the Advising Centers.

Executive Officer of Public Relations

The Executive Officer of Public Relations is responsible for the development of advertising materials for events of the communication with students, the administrators, the community and other colleges, and other areas of student concerns related to campus information. This officer will be in charge of creating student surveys, overseeing the Student Government Association email and maintaining the social media accounts of the Student Government Association.

Executive Officer of Senators

The Executive Officer of Senators will oversee communication between the Executive Committee and Senators. This officer will attend New Student Orientations (NSOs) and will be in charge of recruitment and orientation of Senators. This officer will also promote active communication with the students, the administration, the community, and other colleges and will work in tandem with the Executive Officer of Public Relations to achieve this.

Article III – Committees

Section (C-1)

The Executive Committee shall be composed of all Executive Officers of the Student Government Association. The Committee shall also have other such duties and powers as designated in the General Provision section of this Constitution. Each officer is limited to participation in one College committee unless otherwise approved by SGA Advisor(s). Members who have not established their own committees may be placed to work in another member's committee, upon the approval of the Executive Officers.

Section (C-2)

All standing committees of the SGA shall consist of a minimum of six members (unless otherwise stated) of the Palo Alto Student Community who have applied for and met requirements to serve in an Executive Position. The SGA officers shall be chairpersons of their assigned committees unless otherwise stated. Members of standing committees are selected from the student body and approved by the Executive Committee of the Student Government upon the recommendation of the Executive Officer heading that standing committee. Upon approval, these committee members are designated as Representatives of the Student Government Association. Committee Chairpersons shall vote only in case of a tie.

Section (C-3)

The Elections Committee shall be responsible for conducting fair and impartial elections in accordance with the rules of electoral procedure established in this Constitution. The Committee shall consist of a representative from the Executive Committee, who will not be running in the election in question and a representative from the Office of Student Life.

Article IV - Quorum

Section (Q-1)

A quorum for all regular and special called meetings of the Student Government Association shall be 2/3 of the Executive Committee excluding the President.

Section (Q-2)

A quorum for all committee meetings of the SGA shall be a majority of the total membership of the respective committee, excluding the Chair.

Article V – Elections

Section (E-1)

The Elections Committee shall conduct all regular elections for officers no later than the second week of April before the end of the spring semester.

Section (E-2)

Prospective candidates and current officers must be in good academic and disciplinary standing at Palo Alto College. Any officer who is placed on scholastic or disciplinary probation during their term shall be subject to removal upon the approval of the Advisor(s).

Section (E-3)

Prospective candidates for Office of the President and Vice President of the Student Government Association shall have at least a cumulative Grade Point Average of 2.75 or better, maintain a course load of six semester hours at Palo Alto College unless otherwise approved by an Advisor(s), and have one year of leadership experience at Palo Alto College or otherwise approved by the Advisor(s).

Section (E-4)

All prospective candidates for any Executive Office position must have at least a cumulative Grade Point Average of 2.75 or better, and have a minimum course load of six semester hours at the Alamo Colleges to hold office or otherwise approved by the Advisor(s).

Section (E-5)

All prospective candidates for any office shall file a completed application with Chairperson of the Elections Committee, no later than the date set by the Elections Committee. Only those candidates who have filed an application with the Elections Committee shall be listed on the ballot. The names of the candidates will appear on the ballot by office, in alphabetical order.

Section (E-6)

Write-in candidates will be allowed. All write-in candidates must meet all minimum requirements as outlined in E-4 of the Bylaws and submit an Executive Officer application no later than five school days after the last day of elections.

Section (E-7)

No later than the week before elections, the Elections Committee shall have drawn up election rules and procedures to govern all campaigning and electoral proceedings. The Election Committee may allow voting in by acclamation when candidates run unopposed. The guidelines for the number, size, and placement of all campaign literature, posters, and banners shall be followed by those set by the Elections Committee.

Section (E-8)

The Elections Committee shall hold a candidates meeting prior to each election to distribute and explain all election rules to the candidates. All candidates are subject to the rules established by the Elections Committee and approved by the SGA. Violations of said rules may result in disqualification from candidacy by the Elections Committee and/ or a recommendation for a denial of approval in all further Student Government Association elections.

Section (E-9)

Executive Officers of the SGA are selected by receiving the most votes for that position in an election conducted of all currently enrolled Palo Alto College students.

Section (E-10)

If at any time during the year a position in the SGA becomes vacant, the Executive Committee of the SGA shall appoint an Officer until the next general election.

Section (E-11)

All duly elected SGA officers shall be in compliance with their respective candidacy requirements throughout their terms of office, or face immediate and automatic dismissal from office upon the majority vote by the Executive Committee as outlined in Article VIII.

Article VI - Amendments and By-Laws

Section (AB-1)

All provisions of this Constitution are subject to amendment. Proposed amendments to this Constitution shall be introduced in writing to the Executive Committee of the Student Government Association no less than one regular meeting prior to voting and shall require a 2/3 vote of the voting members present at the meeting for approval.

Section (AB-2)

To change the Bylaws of the SGA, a 2/3 vote of the voting members present shall be required.

Section (AB-3)

Any proposed amendment, together with the parts of the Constitution affected, shall be publicized through all available media to the Student Community.

Section (AB-4)

Proposed amendments shall become effective upon approval of the Student Government, Director of Student Life, the Vice President of Student Success, and the President of the College.

Section (AB-5)

A quorum must be present for a constitutional ratification to take place. The constitution must be ratified by a simple majority.

Article VII - SGA Advisors

Section (A-1)

The Student Government Association may have more than one advisor with at least one being a full-time employee. If no advisors have been approved or if an advisor resigns, the Executive Committee will recommend no less than two (2) and no more than four (4) names to the Vice President of Student Success for approval to serve as advisors. Approval of advisors must also be granted by their department chairperson, Dean and Vice President of Academic Success. An advisor may be removed by 2/3 vote of the Executive Committee of the Student Government Association.

Section (A-2)

The duties of the advisor shall be to offer guidance, encouragement, and support to the organization. Advisors are responsible for verification of grade point averages for all Executive Committee Student Government Association Officers at the close of each semester. At least one advisor must be present at all meetings and functions unless the Executive Committee is otherwise told to proceed in the absence of the advisors.

Section (A-3)

The advisor shall serve as ex-officio, non-voting members of the Executive Committee of the Student Government Association.

Article VIII - Removal

Section (R-1)

An SGA Executive Officer may be removed for failure to maintain the required grade point average, violation of student conduct as specified in the Palo Alto College Student Handbook, failure to attend twenty-five percent of scheduled meetings, events, or activities per semester regular, and failure to execute their assigned duties.

Section (R-2)

In the event that an Executive Officer cannot be present at such a meeting, he or she is to contact another officer in regard to their absence. When any other officer is notified of the absence, the absence is noted on meeting attendance as EXCUSED. The accumulation of three excused absences will result in the Executive Officer being excused of his or her duties in SGA. If any officer fails to give notice of their absence to the President or designee prior to a meeting, it will result in the officer being noted UNEXCUSED on meeting attendance. The accumulation of two UNEXCUSED absences can result in the Executive Officer being removed from his or her position duties in the Student Government Association.

Section (R-3)

The SGA Officer or Advisor must be informed in writing of the charges brought against him or her by the Executive Committee.

Section (R-4)

In the event that the SGA Officer or Advisor wishes to appeal such a decision, he or she may ask for a special meeting with the Executive Officers to discuss the reasons for dismissal. The SGA Officer or Advisor will be allowed one week to prepare his or her defense against the charges. In the event that the Advisor wishes to appeal such a decision, he or she may ask for a special meeting with the Executive Officers to discuss the reasons for dismissal. The SGA Advisor will be allowed one week to prepare his or her defense against the charges.

Section (R-5)

In a closed executive session, the Advisor or Officer will present their case to the Executive Committee. The Executive Committee will vote to determine whether to pursue the removal process. A 2/3's vote by the Executive Committee will result in the final termination of the SGA member or Advisor.

Article IX - General Provisions

Section (GP-1)

The latest revised edition of Robert's Rules of Order shall govern Parliamentary Procedure.

Section (GP-2)

The powers, rights, and privileges granted to the Executive Committee of the Student Government Association by its Constitution shall not be abrogated or usurped by other student organizations at Palo Alto College. All laws therefore now in effect and not in conflict with any provisions of the Constitution and laws shall hereby be declared binding and valid as statutory enactments.

Section (GP-3)

The same person shall not hold two (2) elective offices simultaneously, nor shall two (2) persons simultaneously hold the same elective office. The President, Vice President, and the Secretary of Business and Treasury of the Student Government Association shall not hold an office in any other Palo Alto College club or organization while holding an SGA office unless otherwise approved by SGA Advisor(s).

Section (GP-4)

The Constitution and Bylaws of the SGA shall take effect immediately after ratification by a plurality vote by the members of the Student Government Association and approved by the appropriate college authorities.

Section (GP-5)

The Executive Committee of the SGA shall be empowered to carry out the provisions of the Constitution and Bylaws, shall make such regulations as it considers necessary to attain this end, and shall apply such sanctions as it believes just of infraction of its laws and regulations.

Section (GP-6)

All meetings of the Executive Committee of the SGA shall be open to all students, faculty, and administrators of Palo Alto College. Other guests shall be admitted at the discretion of the presiding officer. The Executive Officers also have the right to call a closed door meeting as directed by the "open meeting" law.

Section (GP-7)

The Student Government Association shall be the highest governing level of student association at Palo Alto College.

Section (GP-8)

All disbursements over \$25 from the General Treasury of the Student Government Association shall be approved by a majority vote or the Executive Committee of the SGA.

Section (GP-9)

The Financial records of the Student Government Association will be available for viewing at any given time.

Article X – Bylaws

Section (B-1)

Every elected official of the Executive Committee of the Student Government Association, before entering office shall take the oath of affirmation: "I______do solemnly swear (or affirm) that I will faithfully execute all the duties of my office and will to the best of my ability to uphold the Constitution and Bylaws of the Student Government Association of Palo Alto College." All elected officials shall be sworn in before the start of their elected term. The outgoing president of the Executive Committee of the Student Government Association shall administer the oath of office or another Executive Committee members in the absence of the president.

Section (B-2)

The Student Government Association shall meet within thirty (30) days after elections. At this meeting of newly elected Executive Committee members of the SGA, the outgoing President of the Executive Committee will complete any outstanding business, and submit an audit of the SGA account or other Executive Committee members in the absence of the President. The newly elected members of the Executive Committee of the Student Government Association will then establish a regular meeting time.
