Notes:

1. The proposed prices for items #6, 8, and 9 were applied to the estimated annual quantity in determining the estimated annual price.
2. The proposal submitted by CampusGuard provided pricing for on-site delivery of services for item #4, \$4,800, item #9 \$24,000, item #10 \$6,000, and was not used in the evaluation.
3. The proposal submitted by Dell Secureworks provided pricing of \$2,000, per week for on-site delivery of items 1 -10, and was not used in the evaluation.
4. The proposal submitted by MGT of America LLC provided pricing of \$250 per day for on-site delivery of items 1 - 10, and was not used in the evaluation.
5. The proposal submitted by Offensive Logic LLC provided pricing of \$1,500 on item #8 for on-demand service, and was not used in the evaluation. Additionally their firms proposal included a %10 discount on items #1 - #10, and was used in the evaluation.
6. The proposal #2 submitted by Weaver and Tidwell included a 10% discount on items #1 - #10, if contracted through their DBITS Cooperative agreement.
7. The proposals submitted by Global Information Intelligence, LLC; Offensive Logic, LLC; Securance, LLC; Trace Security, LLC; True North Consulting Group; VantagePoint Security Inc; and proposal #1, and #2 by Weaver and Tidwell, LLP provided the same price for both on-site and off-site delivery of services, and was used in the evaluation.
