- 1. The proposals submitted by Alamo HR LLC, proposed a 2-Hour minimum charge for assignments. A total of 5 occurrences will be charged under each respective time frame. Occurrences exceeding 5 under each category will result in \$60.00 flat fee charge for each additional cancellation occurrence.
- 2. The proposals, submitted by Alamo City Interpreters LLC, Interpreters Unlimited, Sorenson Communications LLC, and SAI Interpreting and Translation, proposed all services cancelled with less than 24-hour notice to be billed, based on the cost per hour of the original request as listed in Item Nos. 1-7. For evaluations purposes, the proposals were evaluated with a quantity of 2 hours per "SCHEDULED American Sign Language Interpreting Service spoken English (Monday Friday; 8:00am 5:00pm)" occurrence for Line Item Nos. 8 and 9. The actual cancellation fee will be based on the billable rate requested.
- 3. Alamo HR LLC submitted a proposed Payrolling Rate (lower rate) for each item. This rate was not evaluated.
- 4. The amounts shown were evaluated for English translation services, and will be purchased on an as needed basis and represent the Alamo College District's best estimates for a one-year period, the actual amount paid is based on the amount of services purchased.
