Thank you for your letter and prospectus regarding St. Philip's College's request for approval regarding a programmatic award level change for the Surgical Technology Level II Certificate TO the Associate of Applied Science Degree in Surgical Technology, effective fall 2013.

The program level change reflects the healthcare market's need for degreed providers in addition to recommendations of the accrediting body that surgical technology programs evolve to the associate degree level. As the institution currently offers the Level II Certificate in Surgical Technology, existing physical resources, faculty qualifications, library, and learning resources are adequate and appropriate to support this program. The institution currently offers the A.A.S. degree in many other health-related programs.

Documentation of need and demand and appropriate approvals were provided in the prospectus. Following approval to implement the A.A.S. Degree in Surgical Technology, the Level II Certificate will be archived.
